### LAST DATE FOR RECEIPT OF COMMENTS ON TARIFF PETITIONS FILED BY THE DISTRIBUTION LICENSEES EXTENDED TILL 11.06.2011.

1. The Distribution Licensees in the NCT of Delhi viz. BSES Rajdhani Power Ltd. (BRPL), BSES Yamuna Power Ltd. (BYPL), North Delhi Power Ltd. (NDPL) and New Delhi Municipal Council (NDMC) have filed their petitions for true up of expenses for FY 2009-10 and approval of Annual Revenue Requirement (ARR) and tariff for FY 2011-12.
