INTERIM ORDER

(Date of Hearing: 23.01.2018)

(Date of Order: 29.01.018)

1. The instant Petition has been filed by Indian Wind Power Association (IWPA) for seeking directions for compliance of the Renewable Purchase Obligation (RPO) imposed upon the obligated entities in the State of Delhi. The Petitioner has further prayed that strict action in terms of the applicable Regulations be taken against those obligated entities who have failed to comply with their RPO since the notification of DERC (Renewable Purchase Obligation and Renewable Energy Certificate Framework Implementation) Regulations, 2012.
2. None appeared on behalf of the Petitioner.
3. The counsel for the respondents submitted that they have not received the copy of the petition. Registry is directed to provide a copy of the petition to the respondents within a week.
4. The Counsel for the respondents further submitted that for certain reasons the RPO for the previous years could not be complied with and they are willing to comply with the RPO.
5. The Commission observes that Prima facie, it is evident that the respondents have failed to comply with their respective RPO and non-compliance of RPO by the respondents may attract penalty u/s 142 of the Electricity Act, 2003. Therefore, the respondents are directed to file their reply, within 2 weeks, as to why a penalty u/s 142 of the Electricity Act, 2003 should not be imposed on them for violation of provisions of RPO as per the DERC (Renewable Purchase Obligation and Renewable Energy Certificate Framework Implementation) Regulations, 2012.
6. The next date of hearing will be informed in due course.
7. Ordered accordingly.
