INTERIM ORDER

(Date of Hearing: 24.07.2018)

(Date of Order: 30.07.2018)

1. The counsel for the petitioner submitted that in compliance to the Commission's Order dated 07.06.2018, the necessary documents such as the Audited Statement of the petitioner's 12 MW Integrated Waste to Energy Power Plant at Ghazipur from 2008 onwards and the Memorandum of agreement with IL&FS Environment Infrastructure and Services Ltd. (IEISL) have been filed on affidavit and it was further requested that the Commission may determine an interim tariff for the waste to energy project pending disposal of the current proceedings.

2. The Counsel for the respondent no. 2, BRPL and respondent no. 3, BYPL submitted that they have not received the copy of the affidavits filed by the petitioner.
3. The petitioner is directed to provide a copy each of the affidavits to the respondents within 2 days.
4. Further, the Commission observes that information and the data such as adoption of competitive bidding process, breakup of capital cost escalation etc. needs corroboration, therefore the petitioner is directed to have meetings with the officers of the Commission within one week to explain and verify the data filed by it in order to substantiate its claim about the capital cost of the project. The petitioner shall also provide a copy of the Memorandum of Understanding dated 27.09.2010 signed by IL&FS through its subsidiary IEISL.
5. The matter is listed for hearing on 31.07.2018.
6. Ordered Accordingly.
